



## Choosing a Certified Irrigation Contractor

Below is a list of landscape and irrigation contractors who are licensed contractors in the State of Washington and certified by the Irrigation Association (IA), Washington Association of Landscape Professionals (WALP), the Irrigation Water Management Society (IWMS), or the US Environmental Protection Agency (EPA) WaterSense Program. To qualify for the Saving Water Partnership's Sprinkler System Rebates, all services must be provided by a landscape contractor licensed and bonded in Washington State. ## The Certified Professional Advantage

The Saving Water Partnership recommends that you choose a landscape contractor who is certified as an irrigation specialist by a professional organization. A certified irrigation specialist is your best resource for quality system maintenance and repair.

Below is a brief description of each certification:

### **Irrigation Association (IA)** [www.irrigation.org](http://www.irrigation.org)

#### **Certified Irrigation Contractor (CIC)** [www.irrigation.org/cic/](http://www.irrigation.org/cic/)

Manages contracts and subcontracts to install, repair, and maintain irrigation systems in such a manner that projects can be executed in an acceptable way, meeting all specifications and requirements, including irrigation layout, installation, maintenance and repair of systems.

#### **Certified Irrigation Designer (CID)** [www.irrigation.org/cid/](http://www.irrigation.org/cid/)

Evaluates site conditions and determines net irrigation requirements based on the needs of the project, including selection of the most effective irrigation equipment and design methods. The objective of a CID is to establish specifications and design drawings for the construction of an irrigation project.

#### **Certified Landscape Irrigation Auditor (CLIA)** [www.irrigation.org/clia/](http://www.irrigation.org/clia/)

Collects landscape data, makes irrigation maintenance recommendations, performs irrigation system audits, and develops base irrigation schedules.

#### **Certified Landscape Water Manager (CLWM)** <http://www.irrigation.org/clwm/>

Evaluates, operates, manages and improves landscape irrigation systems to achieve the highest level of water conservation possible.

**Washington Association of Landscape Professionals (WALP)** [www.walp.org](http://www.walp.org)

**Certified Landscape Technician (CLT-Ir)**

Understands basic landscape maintenance practices, and demonstrates irrigation system and water management skills.

**Irrigation Water Management Society (IWMS)** [www.iwms.org](http://www.iwms.org)

**Certified Site Water Planner (CSWP)** [www.iwms.org/CSWP.html](http://www.iwms.org/CSWP.html)

Develops comprehensive site water management plans based on historical site water use and particular site conditions, and makes cost-effective water conservation measures related to landscape and irrigation system water efficiency.

**WaterSense**

WaterSense is a labeling program for water-efficient products and services (the water version of EnergyStar). WaterSense also labels certification programs for irrigation professionals. WaterSense irrigation professionals are certified through WaterSense labeled programs for their expertise in water-efficient irrigation technology and techniques.
