Water Conservation Rebate for Efficient COIN-OP Clothes Washers

To be eligible for the **LaundryWise** rebate, a clothes washer must be:

- Installed in a Saving Water Partnership service territory (see box, below right)
- Coin-operated and used as a common-area laundry (typically an apartment or condominium building)
- Purchased, or have a lease agreement of five years or more
- Listed on the official **LaundryWise** list (on the back of this application)

Rebate Procedure

1. Confirm the building is located in the Saving Water Partnership service territory (see list, below left)
 2. Purchase a Coin-op Clothes Washer that is eligible for the rebate (see backside or www.savingwater.org)
 3. Complete this application.
 4. Send in the application along with a copy of the purchase receipt (listing the brand and model) and the delivery installation receipt. If the machine is leased, please provide documentation that the lease is five years or longer.

Coin-op Clothes Washer Rebate: \$100 or \$125

The following coin-op clothes washers are eligible for a \$100 or \$125 rebate, for customers who purchase water from a Saving Water Partnership utility. The rebate is based on how much energy and water a machine saves: the more the machine saves, the higher the rebate (see <http://www.cee1.org/com/cwsh/cwsh-main.>) This rebate program is sponsored by the Saving Water Partnership.

Compared to a standard washer...

Two Stars: reduces both energy and water use by **35%** or more

Three Stars: reduces both energy and water use by **42%** or more

Notes:

- Customers of the 18 Saving Water Partnership water utilities are eligible for the rebates indicated above, regardless of whom provides electricity to the residence.
- If the clothes washer is not listed above, it is NOT eligible for the Saving Water Partnership rebate. * Indicates there may be additional numbers or letters at the end of the model number.
- Machines in each category must meet that category's savings criteria for **both energy and water**. For example, some of the "two star" machines save enough energy to be considered "three star" for energy alone, but the "two star" water-efficiency of the machine keeps it as a "two star" rather than a "three star" machine.
