## Application Procedure

2. Complete this application.

4. In most cases a site visit will be scheduled after application review, and information will be collected as necessary to review the proposed project. An approval letter or participation agreement to proceed with the project will follow the site visit.
5. Applicant completes the project, submits relevant supporting documents to SPU, and schedules a project inspection.
6. Completed project is approved and final incentive is paid.
