

# COMMERCIAL TOILET & URINAL REPLACEMENT REBATE - \$100 REBATE PER FIXTURE

## TAKE THESE 4 EASY STEPS:

1. Check to see if you are eligible for this program by confirming the facility is located in the Saving Water Partnership Utilities – see blue box at right.
2. Complete the application digitally (fill out PDF form & click Submit Button) or print and complete the application and send by mail, fax or email (information below in green box).
3. An onsite visit will be scheduled if necessary, followed by an authorization letter detailing the steps to receiving the rebate. Fixtures must be purchased and installed after you receive an authorization letter. All fixtures installed must be WaterSense labeled or high efficiency - [www.epa.gov/WaterSense/product\\_search.html](http://www.epa.gov/WaterSense/product_search.html) or Premium 1.1 gpf list on [www.savingwater.org/rebates](http://www.savingwater.org/rebates).
4. Complete your project and submit project completion information by December 15, 2019.
