- Existing toilets must be pre-2004 and have not been rebated before.
- The application must be submitted within 60 days of purchasing the new toilet(s).
- Maximum of two (2) rebates per household.
- This application is for single family residences, duplexes, triplexes and condo owners.

 - Copy of purchase receipt (must include method of payment and the toilet model # or SKU #)
 - Copy of recent water bill (for the property where the toilet will be installed)

5. Receive your rebate check in the mail within 30-45 days.
